## FROM THE EXECUTIVE DIRECTOR AND BOARD PRESIDENT

### Dear Friends,

The year 2021 was pivotal for Neighborhood Health's work to increase health equity in Northern Virginia.

We started the year on a hopeful note. After the difficult early months of the pandemic, we began vaccinating our team members and patients against COVID-19. The pandemic's persistence, however, made for a challenging year for all of us.

Despite these challenges, we made an impact in significant ways.

We provided primary care to more than 32,000 patients—predominately low-income, immigrant, uninsured or underinsured, and people of color—who continue to be disproportionately impacted by the pandemic.

As one of the first health centers nationally selected for the U.S. Health Services and Resources Administration (HRSA) Health Center COVID-19 Vaccine Program, we designed our vaccine rollout with equity as the primary focus. We reached the communities most impacted by the pandemic by enlisting 150 partner organizations—houses of worship, affordable housing organizations, social service organizations, local government agencies, and many others—in this effort.

We administered more than 74,000 vaccines in 2021. These vaccines were provided to Neighborhood Health patients and an additional 25,000 community members most in need. Our efforts were recognized by President Biden when he visited one of our vaccine clinics in April 2021. Subsequently, we were selected among the first health centers

for the HRSA COVID-19 Testing Supply and Therapeutics Programs.

In 2022, our 25th year, we continue to respond to the pandemic in our most under-resourced communities. We are building on our pandemic response and our new partnerships to facilitate access to primary care to those who need it most. This is evident through our work with resettlement agencies to provide a medical home for incoming Afghan refugees.

We continue to expand access to care in areas of high need. This includes a new clinic in Annandale that opened in early 2022 and additional clinics planned in the coming years in partnership with our local jurisdictions. And, HRSA has recognized Neighborhood Health once again for our outcomes in providing patients with high-quality care.

This progress would not be possible without your support. Whether you have been involved with our work since our early days or as a more recent supporter, we are grateful for your contribution. We look forward to continuing our work together to advance health equity in Northern Virginia.

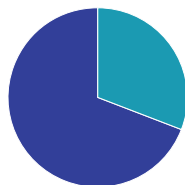

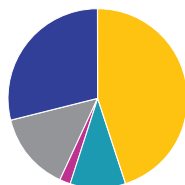

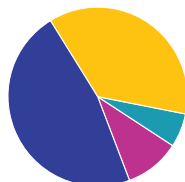

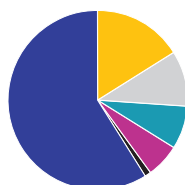

# Neighborhood Health's COVID-19 Response

Low-income communities of color have been disproportionately affected by the pandemic—both in terms of the prevalence of the virus in these communities, and the economic challenges it has created. These are the communities Neighborhood Health serves.

Our pandemic response started with our own patients and then extended deeper into local communities. The partnerships we developed and strengthened throughout the year were pivotal in helping us mobilize, communicate, and ultimately reach those most in need.

## COVID-19 Vaccine Clinics

In collaboration with community partners, we initially set up seven vaccine clinics in carefully targeted areas of Alexandria, Arlington, and Fairfax County. A simple online referral process was created for use by local community-based organizations. We also began to offer vaccines at all of our medical clinics to anyone who walked in. More than 75 clinic volunteers assisted us, along with Medical Reserve Corps from Alexandria and Fairfax counties.

## Pop-Ups & Mobile Vaccine Clinics

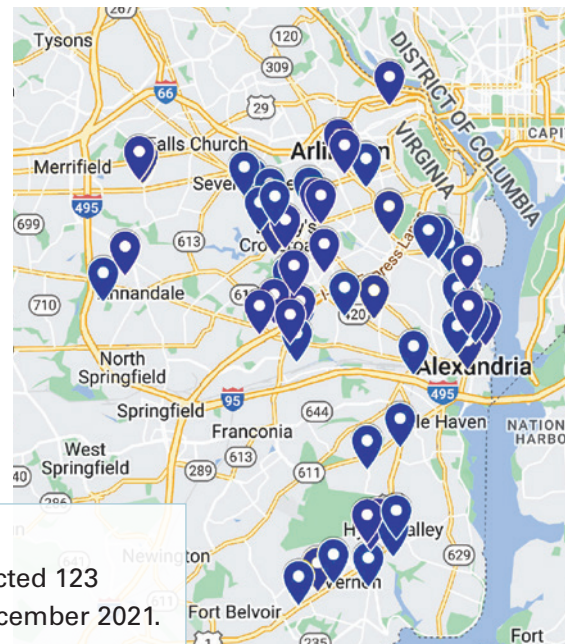
We brought the vaccines even closer to where low-income populations live and work, hosting events in partnership with low-income housing developments, faith communities, and safety net agencies. We even purchased a vaccine van to continue this work in places without indoor space. Neighborhood Health hired 10 outreach workers to take messaging door to door in the communities most impacted by COVID-19 and with the lowest rates of vaccine uptake.

*Trust is critical for increasing vaccine acceptance among marginalized populations. There are two reasons our vaccine response worked so well: First, we enlisted trusted and familiar messengers—pastors, community service agencies, low-income housing staff. Then, we removed as many other barriers as possible and made the process easy for people.*

In coordination with our partners, we conducted 123 pop-up/mobile events from May through December 2021.

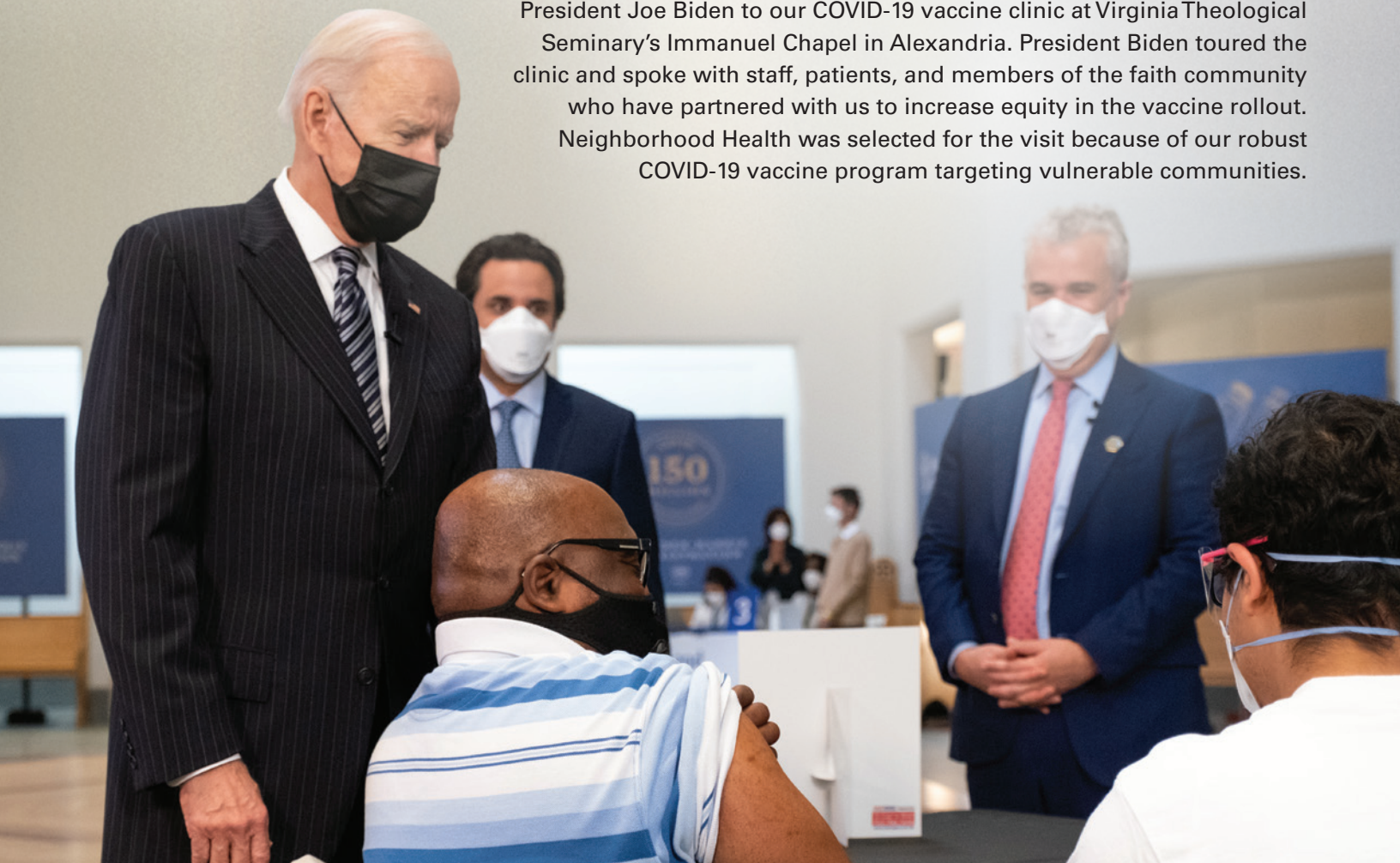






## President Biden Visits Neighborhood Health COVID-19 Vaccine Clinic

On April 6, 2021, Neighborhood Health had the honor of hosting a visit from President Joe Biden to our COVID-19 vaccine clinic at Virginia Theological Seminary's Immanuel Chapel in Alexandria. President Biden toured the clinic and spoke with staff, patients, and members of the faith community who have partnered with us to increase equity in the vaccine rollout. Neighborhood Health was selected for the visit because of our robust COVID-19 vaccine program targeting vulnerable communities.

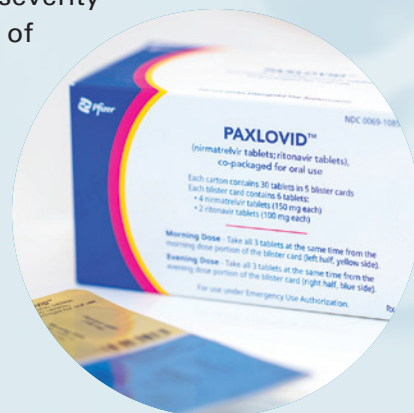


## Expanding Access to COVID-19 Therapeutics

Pauline,\* a 52-year-old Neighborhood Health patient, takes medication for hypertension, and has impaired kidney function and colon cancer. Due to her cancer treatment, she was unvaccinated against COVID-19.

In January 2022, Pauline went to the emergency room for cancer-related pain and, while there, tested positive for COVID-19. She was at very high risk of developing severe complications due to being actively treated with chemotherapy and unvaccinated.

At this time, Neighborhood Health had received our first doses of Paxlovid, a COVID-19 oral antiviral that is effective at reducing the severity of symptoms. We were one of the first 200 health centers in the country selected to participate in the initial pilot of the HRSA Health Center COVID-19 Therapeutics Program to ensure equitable access





## COVID-19 Testing

Neighborhood Health set up multiple free drive-through and walk-up COVID-19 testing sites in areas that experienced high disease burden at the height of the pandemic. These included clinics set up with community partners such as Casa Chirilagua in Arlandria (Alexandria) and Culmore Clinic in Culmore/Bailey's Crossroads (Fairfax County).

Neighborhood Health Family Nurse Practitioner Alissa Wong thought Pauline was an excellent candidate for Paxlovid. She worked with Pauline's oncologist and others to ensure Pauline could receive the medication. They coordinated medication changes with our pharmacist, and a staff member delivered the medication to Pauline's home.

Pauline reported that her symptoms disappeared quickly, and she was able to resume chemotherapy. She is grateful for Neighborhood Health having access to the antiviral medication, dispensing it so quickly, and delivering it so she could remain safely isolated at home during her illness.

## Community Partnerships: Increasing Access to Vaccines and Testing

Neighborhood Health engaged with over 150 community partners to make sure COVID vaccines and home test kits were available to all. Partner organizations referred tens of thousands of people for vaccines, hosted vaccine clinics, invited our communications team to present to their clients, put up flyers, provided incentives to encourage vaccine uptake, and distributed thousands of at-home test kits.

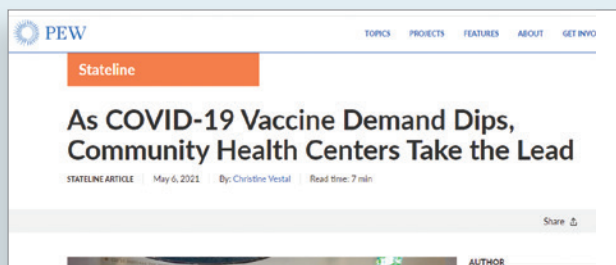
## At-Home Test Kit and N95 Mask Distribution

Neighborhood Health has distributed more than 27,000 at-home test kits and more than 11,000 N95 masks to our patients and community partner agencies to date. Partners include food banks, low-income housing providers, faith communities, and more.

# Advancing Health Equity in 2021

## Providing Health Care to Afghan Refugees

When the Afghan refugee crisis emerged, our health center rallied immediately to help. We have partnered with the three local resettlement agencies (Catholic Charities of the Diocese of Arlington, Ethiopian Community Development Council, and Lutheran Immigration & Refugee Services) to facilitate entry into ongoing primary care for newly arriving Afghan refugees.

To address ongoing health concerns for our new Afghan neighbors, we have hired a Dari-speaking case manager to better coordinate care through the health system and to help with interpretation at appointments. To date, we have provided ongoing medical care to more than 500 refugees.



## Improving Care for Patients with Hypertension

On January 2021, Neighborhood Health began participating in a three-year HRSA “National Hypertension Control Initiative: Addressing Disparities among Racial and Ethnic Minority Populations” to increase the number of adult health center patients with controlled hypertension. The initiative focuses on the evidence-based use of Bluetooth®-enabled self-monitoring blood pressure cuffs to allow patients to collect readings at home. We teach patients how to properly measure their blood pressure and how to link the device. Results populate directly into the electronic medical record so the medical provider can review the readings and make treatment changes via telehealth visits.



## Getting Children Caught up on Well-Child Checks


Neighborhood Health was awarded a grant to pilot a program aimed at increasing well-child visits. As part of the pilot, the pediatric team offered a Back-to-School physical day where 80 children had a well-child visit, as well as received backpacks and school supplies. The program was so successful that it was selected as one of 20 national prize winners!



## Increased Access to Family Planning Services

Over the past two years, Neighborhood Health has started to offer a much wider variety of family planning options to meet the needs of our patients. This means that women no longer have to apply for free contraceptive devices from a pharmaceutical company and wait up to six weeks to receive it. This point-of-service availability has led to a substantial uptake.





# Helping a Child Be a Child Again by Providing Access to Care at a Critical Time

Last June, 11-year-old Belén\* and her family came to Neighborhood Health's Casey Clinic, and they were desperate. Belén had experienced many episodes of arrhythmia (irregular heartbeat) throughout her life and they only had two days left of the medication she needed to keep her heart functioning normally. They had been to emergency rooms and other clinics in the area for a medication refill, but because she was uninsured and did not yet require acute care, no one was able to help. Someone told the family about Neighborhood Health, so they stopped into the clinic—a decision that saved Belén's life.

In her home country of Honduras, Belén had been diagnosed with a heart condition, placed on medication, and told that her episodes were so difficult to treat that she would likely not live beyond her 15th birthday. She was not allowed to run or be active, and she was very anxious about going to school in case she had an episode there. Because of her medical condition, Belén's mother made the difficult decision to leave their home country to come to the United States.

Neighborhood Health pediatrician Dr. Carolina Saldarriaga Perez saw Belén and her mother in clinic and was determined to help this family. They had extensive medical records documenting Belén's medical history and treatment, including several EKGs. Dr. Saldarriaga Perez noticed that some of the EKGs, along with some of Belén's symptoms, seemed to be inconsistent with her diagnosis. She did research and suspected that Belén might have a different—still very serious and life-threatening—but treatable heart condition. She reached out to a pediatric electrophysiologist colleague at Inova who reviewed the EKG readings and agreed. They determined the best course of action was to immediately admit Belén into Inova's Pediatric ICU so she could be closely monitored.

Belén's new diagnosis was confirmed, and she underwent a cardiac ablation procedure to address the arrhythmia. Dr. Saldarriaga Perez explained everything to the family in Spanish. She also visited Belén and her mother in the hospital after the procedure to answer their questions and allay their fears.

Dr. Saldarriaga Perez continues to see Belén for her pediatric care. She no longer needs to take any medication, is allowed to run and play, and is a straight-A student. Belén and her mother are incredibly grateful that Dr. Saldarriaga Perez and Neighborhood Health were willing to take such attentive and thorough care of them when they had nowhere else to turn.

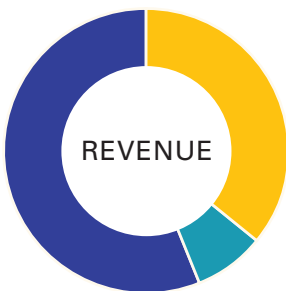

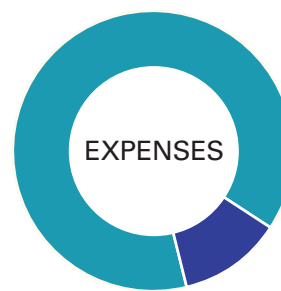

# Looking Ahead...

Neighborhood Health has plans to continue to expand access to care for those most in need who live in the City of Alexandria, Arlington County, and Fairfax County. There continues to be an unmet need for primary health care services for uninsured and underinsured individuals in our service area.

---

In January 2022, we opened a new site in Annandale, an area of high unmet need in our service area, where we are providing family medicine and women's health services. We plan to expand clinic services at this location to include pediatrics and behavioral health. This complements the dental clinic we opened several years ago in Annandale.



In early 2023, we will be moving into a new site at Mark Center in the West End of the City of Alexandria. This site will be co-located with the City of Alexandria's Department of Community and Human Services and Department of Health. Co-location will provide opportunities for staff to better coordinate services for our clients.



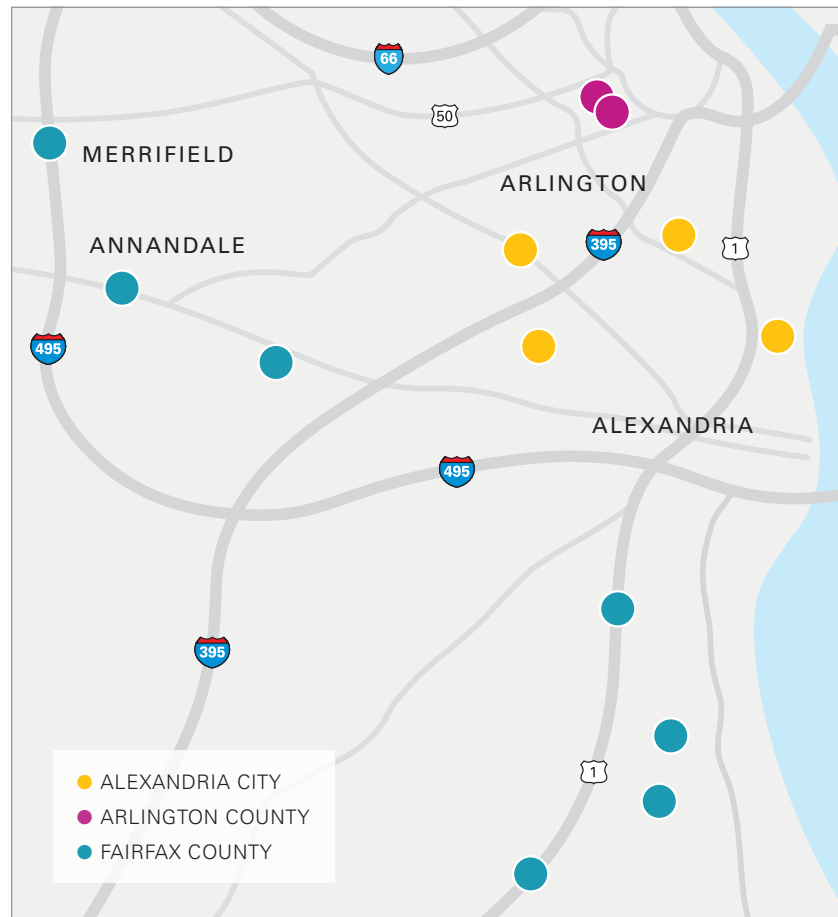
We also look forward to celebrating our 25th Anniversary! In 1997, community members from the City of Alexandria established a non-profit organization, Alexandria Neighborhood Health Services, Inc. (ANHSI), to support and operate a small clinic providing primary care for low-income women and children in the city's Arlandria community.

ANHSI became an FQHC in 2004 and has grown into a thriving organization – now known as Neighborhood Health – serving more than 32,000 patients at 14 clinics in the City of Alexandria, Arlington County, and Fairfax County. We are constantly driven by our mission to improve health and advance health equity by providing high quality primary medical, dental, and behavioral health care regardless of ability to pay.
