FROM THE CHIEF EXECUTIVE OFFICER AND BOARD PRESIDENT

Dear Friends,

In 1994, the Alexandria Health Department opened a small clinic in an apartment building in Arlandria-Chirilagua to provide basic healthcare to low-income immigrant women and children. In 1997, when the grant that funded this clinic was set to expire, community members established a non-profit organization, Alexandria Neighborhood Health Services, Inc. (ANHSI), to support and expand the clinic.

Twenty-five years later, this same organization—now known as Neighborhood Health—is serving almost 35,000 patients in fourteen clinics across Northern Virginia. Our services have expanded extensively. What has remained constant is our focus on the most under-resourced members of our community. The vast majority of our patients are low-income, lack health insurance, or are insured through Medicaid.

In 2022, we continued to expand access to care by opening two additional clinics, in Annandale and Alexandria. We obtained Joint Commission ambulatory care reaccreditation—a reflection of our commitment to provide high-quality care to our patient population. Other highlights include our ongoing COVID-19 response with more than 90,000 vaccines given to date; the establishment of a new vision services program; and resumption of services on our "Wellness on Wheels" bus in partnership with Alexandria City Public Schools.

Looking ahead, we are opening a new clinic at the Mark Center, where primary care will be co-located with social services and public health (Alexandria's Department of Community and Human Services and Health Department). We are expanding our prenatal

program from one location (Casey Health Center) to our entire service area. We are expanding services in Fairfax County by renovating two clinics—in Annandale and along the Route 1 Corridor.

While we continue to make progress, significant challenges remain. Our pandemic era funding is expiring, yet demand for our services remains high. Many of our patients, particularly those without insurance, struggle to access services that we do not offer. With the end of the public health emergency and Medicaid redeterminations resuming, many people will lose coverage—further increasing demand on our clinics.

As we work to overcome these barriers, we will continue to count on your support. For the last twenty-five years, you have helped us build this organization. Whether as an employee, a board member, volunteer, funder, supporter, or community partner, you have helped us make an impact where it is needed most. We are grateful to each and every one of you, and we look forward to continuing our work together to ensure that everyone in our community has access to care.



Highlights

Increasing Access to Care

To increase access to care in our service area, Neighborhood Health opened two new clinical sites in 2022 – one in Annandale and the other in the City of Alexandria.



In January, we opened a new clinic in Annandale, an area with high unmet need. In 2022, our team of three medical providers served more than 2,000 patients – 73% were new to Neighborhood Health. We will be adding


behavioral health and pediatric optometry (see "Looking Ahead" on page 13).



In June, we opened our Martha Custis Drive clinic in the City of Alexandria to relieve patient and clinician congestion at our 2 East Glebe and Casey Health Center locations. We are currently offering women's health and

adult medicine services at this clinic, and in 2022 already served more than 2,600 patients, including more than 500 new patients.

New Service: Pediatric Optometry

In 2022, Neighborhood Health began new pediatric vision services providing comprehensive eye exams and glasses for our youngest patients at our Richmond Highway clinic. These services are otherwise incredibly hard to access for both Medicaid and uninsured patients.



Since starting the program in late
September 2022, we served more than 300 patients. See "Looking Ahead" on page 13 for service expansion in 2023.

COVID-19 Pandemic Response Continues

In 2022, Neighborhood Health continued our pandemic response on multiple fronts. We continued to provide COVID-related services for patients and to the under-resourced communities in the region: vaccines, testing, home test kits, and masks. COVID-19 vaccines are offered to the community on a walk-in basis at our medical clinics and through more than 40 mobile vaccine clinics in 2022.

Closing the COVID-Induced Cancer Screening Gap

Many providers experienced a decline in cancer screening rates during the pandemic. Thanks to funding from the Virginia Department of Health and the American Cancer Society as well as community partners, we continue to make strides in connecting uninsured patients to cervical, breast, and colorectal cancer screenings. This includes our Every Woman's Life program with which we have expanded breast and cervical cancer screenings. We have also expanded our gynecology program to provide more treatments within our clinics, reducing the need for outside referrals.



In December, Jahan Dotson, Washington Commanders player and American Cancer Society-NFL Crucial Catch Program Ambassador, met with patients who have benefited from our colorectal and breast cancer screening initiatives.

Our Patient at Seven Years Old – Today Our Health Center Employee

Samantha Cruz-Benitez and her family moved to the Arlandria-Chirilagua neighborhood of the City of Alexandria when she was seven years old. Her parents brought her to Neighborhood Health's (then ANHSI) clinic at 2 East Glebe Road. Her pediatrician was Dr. Martha Welman, who was hired as the organization's first physician and now serves as Chief Medical Officer.

Samantha continued to get her pediatric care at Neighborhood Health and returned when she was an adult. In the meantime, she got her Medical Assistant (MA) certification, and started working in Neighborhood Health's call center. Soon, she moved to front desk, and during the COVID-19 pandemic started working as a Medical Assistant doing COVID-19 testing.

Currently, Samantha works in our Prenatal Care Program alongside MAs Dina and Maricela – both of whom worked in our pediatric program when Samantha was our patient.

"I love giving back to the community and making sure our pregnant patients, many who are new to the United States, feel supported and receive prenatal care, plus any other care that Neighborhood Health offers and they might need," said Samantha.



LOOKING AHEAD...

Strengthening Partnerships and Increasing Access

Prenatal Expansion

We started our prenatal program at the Casey Health Center in 2019. Due to the program's success, growth, and increasing demand from patients, we are planning to expand prenatal services, integrated with primary care, to more clinics across our service area starting in 2023.



Mark Center Drive

In 2023, we opened a clinic in the City of Alexandria's new Del Pepper Community Resource Center building in collaboration with the Department of Community and Human Services and Department of Health. We are excited to co-locate primary care, social services, and public health services in the West End.



Annandale Renovation & Expansion

In 2022, we opened a new medical clinic in Annandale in response to the high need in surrounding communities. In 2023, we renovated and expanded the clinic, enabling us to serve additional patients and adding services such as behavioral health and optometry.

Richmond Highway Renovations

In 2023, we will extensively renovate our 6677 Richmond Highway location. We will be adding an in-house pharmacy, providing low-cost and free medications, additional exam rooms to expand capacity, and two additional dental chairs.

Housing Alexandria Arlandria-Chirilagua Clinic

We are excited to be partnering with Housing Alexandria to include a clinic within their planned Arlandria-Chirilagua development called "Sansé and Naja." It will contain 474 units of affordable housing. Our current East Glebe Road clinic will move into larger space co-located within this development and enable us to expand services within the

same building where many of the patients that we serve will live.
